Dear Mr. Smalley:

On December 27, 2005, a Permit to Install (number 06-7880) was issued to you for sewage system improvements for the Mineral Springs Lake Farm Resort which consisted of 240 camp sites. The PTI did not include the installation of sanitary sewers to serve any new sites. According to the Adams County Health Department the resort now consists of more than 400 camp sites. The installation of sanitary sewers without obtaining a Permit to Install is a violation of the Ohio Administrative Code Rule 3745-42-02(A)(1) and a referral will be sent to our legal staff for formal enforcement action.

Permit to Install 06-7880 contained several special conditions concerning the treatment system. Please review the following:

1. Special Terms and Conditions, Item 2, requires the permittee to hire a professional engineer to prepare an operations and maintenance manual for the treatment and irrigation systems. Two copies of the manual were to be sent to this office for approval. Please submit the two copies of the manual to this office.
2. Special Terms and Conditions, Item 14, requires the owner to keep records available for review by Ohio EPA upon request. Please submit copies of the records cited in Item 14 to this office.
3. Special Terms and Conditions, Item 17, requires the permittee to hire or contract a certified operator to oversee the wastewater treatment plant. The operator was to file a weekly report with owner which contained process control tests, samples collected with analytical results, repair and maintenance performed, and recommendations made to the owner. Please submit copies of the operator's weekly reports to this office.

Please prepare "As built" drawings, applications with fee for the previously installed sanitary sewer extension as well as the other requested information in this letter. If you have any questions, please call me at (740) 380-5268.
