Dear Mr. Colalella:

On September 6, 2013, Ohio EPA received a complaint regarding the mismanagement of used oil and tires at DLC Truck & Tire Repair's Steubenville, Ohio facility. On September 18, 2013, Dale Warner and I inspected DLC Truck & Tire Repair to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). During the inspection we also helped you identify ways to prevent pollution by reducing waste. This letter will explain the violation we found and what you need to do to correct the violation.

We found the following violation of Ohio's hazardous waste laws:

1. **Used oil storage requirements for generators, OAC rule 375-279-22(C)(1):**  
Containers and aboveground tanks used to store used oil at generator facilities must be labeled or marked clearly with the words "Used Oil."

During the inspection, the used oil tank was not labeled as required above; however the used oil tank was labeled during the inspection therefore no further action is required.
