Dear Mr. McCann:

On April 18, 2011, I inspected the 3D Automotive, Inc. (3D Automotive) facility in Radnor, Ohio to determine 3D Automotive's compliance with Ohio's hazardous waste laws and rules as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745. of the Ohio Administrative Code (OAC). Thank you for accompanying me during my inspection. At the time of the inspection, 3D Automotive was operating as a used oil generator. No hazardous waste is generated on site.

During the inspection, I found the following violation of Ohio's used oil rules. In order to correct this violation, you must do the following and send me the required information **within 30 days** of your receipt of this letter:

1. **OAC Rule 3745-279-22(C)(1), Used oil storage requirements for generators – labels:** Containers and aboveground tanks used to store used oil at generator facilities must be labeled or marked clearly with the words "Used Oil."

At the time of the inspection, the used oil tank and totes were not labeled or marked with the words "Used Oil."

- 3D Automotive must label or mark the used oil tank and totes with the words "Used Oil" and submit photographic documentation to me **within 30 days** of receipt of this letter to demonstrate compliance with this rule.

PROCESS DESCRIPTION SECTION

Give a general process description (include all processes at the facility)

Since 2003, 3D Automotive, Inc. (3D Automotive) has been operating an auto repair shop at 4156 Radnor Road, Radnor, Ohio. Previously, Bauerly Automotive operated at this site. 3D Automotive provides many auto repair services, including tune ups; wheel alignment and balance; engine repair; tire service; lube, oil, and filter changes; preventative maintenance; suspension and shock repair; and belt and hose replacement, among others. 3D Automotive does not perform any body work at this shop.

WASTE ACTIVITIES AND P2 SUMMARY SECTION

3D Automotive generates used oil at this location, but does not generate any hazardous waste. The company uses two parts cleaners, but they both contain nonhazardous solvent (Crystal Clean Premium 142+ Mineral Spirits). 3D Automotive generates used oil, which is stored in totes and a tank prior to burning it in the on-site space heater. When the nonhazardous solvent is spent, it is mixed with the used oil and also burned on site in the space heater.

Spent batteries are sent back to Washington Auto Parts to be recycled, and scrap tires are sent to Liberty Tires.



**USED OIL INSPECTION CHECKLIST
