Dear Mr. Henderson:

On March 2, 2011, I inspected the Henderson Trucking facility in Delaware, Ohio (formerly S.E. Johnson Company), to determine Henderson Trucking's compliance with Ohio's hazardous waste laws and rules as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745. of the Ohio Administrative Code (OAC).

Henderson Trucking is a trucking company that hauls sand, stone, and gravel. The company services its trucks at the garage located at 124 Henderson Court, Delaware, Ohio. Henderson Trucking generates used oil at this location, but does not generate any hazardous waste. At the time of the inspection, I found the following violation of Ohio's used oil rules.

***OAC Rule 3745-279-22(C)(1), Used oil storage requirements for generators:*** Containers and aboveground tanks used to store used oil at generator facilities must be labeled or marked clearly with the words "Used Oil."

At the time of my inspection, the totes being used to store used oil were not clearly labeled or marked with the words "Used Oil."

On March 3, 2011, Henderson Trucking e-mailed me documentation demonstrating that the totes being used to store used oil were marked with the words "Used Oil." The violation was abated at that time.

Henderson Trucking is a trucking company that hauls sand, stone, and gravel. The company services its trucks at the garage located at 124 Henderson Court.

Henderson Trucking generates used oil at this location, but does not generate any hazardous waste. The company uses a parts cleaner, but it is a nonhazardous solvent (Zep Dyna 143). Henderson generates used oil, which is stored in totes and then burned in the on-site space heater.
