Dear Mr. Gawelek:

On March 4, 2008, I inspected Weyerhaeuser's facility in Delaware, Ohio, to determine Weyerhaeuser's compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745. of the Ohio Administrative Code (OAC). At the time of my inspection, Weyerhaeuser was not generating any hazardous waste at the containerboard packaging or ink plant. However, Weyerhaeuser is a used oil generator and a small handler of universal waste at this location.

During my inspection, I found the following violation of Ohio's universal waste rules:

1. **OAC Rule 3745-273-14(A), Labeling/markings - standards for small quantity handlers of universal waste:** Universal waste batteries (i.e., each battery), or a container in which the batteries are contained, must be labeled or marked clearly with any one of the following phrases: "Universal Waste - Battery(ies)," or "Waste Battery(ies)," or "Used Battery(ies)."

Weyerhaeuser did not have the container in which its universal waste batteries were contained labeled or marked clearly with one of the following phrases: "Universal Waste - Battery(ies)," or "Waste Battery(ies)," or "Used Battery(ies)."

During the inspection, Weyerhaeuser labeled the container in which its universal waste batteries were contained with the phrase "Used Batteries." The violation was abated at that time.

General Comments

1. During the inspection, we discussed the requirements for universal waste lamps and batteries. As such, I have included additional guidance about universal waste for future reference.

PROCESS DESCRIPTION SECTION

Give a general process description (include all processes at the facility)

At this location, Weyerhaeuser has two operations: a corrugated packaging facility that converts containerboard into corrugated boxes, and an ink plant. Although RCRAInfo lists Weyerhaeuser as a CESQG, the facility does not generate any hazardous waste. However, the company is a used oil generator and a small universal waste handler for bulbs and batteries.

Weyerhaeuser is one of the largest box manufacturers in the country, and the Delaware plant supplies corrugated sheets and packaging to more than 200 customers. Large rolls of paper are brought to the facility via trucks and rail and then fed through the corrugator. The corrugator uses an adhesive (cornstarch/water + liquid caustic) to bond the papers together. Then, some of the corrugated paper is either put through the labeling machine and a rotary die cutter or directly through the rotary die cutter. The facility has three rotary die cutter machines that cut the corrugated paper into specific shapes/boxes depending on customers' needs. After that, the cut corrugated boxes can be sent through the folder and gluer machines. To make cartons, the corrugated paper is sent through the facility's flexo machines. Depending on the size of the carton, the facility can use either a jumbo flexo or a small flexo. The flexo machines cut, ink (with water-based ink), fold, and glue cartons together. The products are then banded and sent out.

All of the facility's scrap paper is collected, baled, and sent back to the company's paper mills to be reused. Wash-up water from the machines is collected, pumped to a wastewater treatment unit (WWTU), and then discharged to the City of Delaware's POTW. The filter cake from the WWTU is nonhazardous, since the facility uses all water-based inks. However, it is still recharacterized annually. Weyerhaeuser sends its used oil to Veach Oil and its universal waste to Resource One.

Weyerhaeuser also operates an ink plant and a color lab (Specialty Products) to make water-based ink (hi gloss, matte, regular). The facility mixes raw materials (water-based) with a caustic or MEA (to balance pH) to make the ink and stores the product in either 5-gallon buckets or totes. Weyerhaeuser also accepts off-spec material from its customers and reuses it by making it into black ink. All of the wash water from the ink plant is pumped to and treated in the packaging plant's WWTU.

Used oil – Used oil is stored in containers in the west end of the corrugator area of the plant. It is sent to Veach Oil Company in Illinois.

Universal waste batteries – Universal waste batteries are accumulated in a container and then sent off site to Resource One.

Universal waste lamps – At the time of my inspection, Weyerhaeuser was not accumulating any universal waste bulbs. However, they are to be sent to Resource One. The facility has also been replacing its bulbs with green tipped bulbs.

Wash-up water – Nonhazardous wash-up water is generated from the plant's machines and the ink plant. It is collected, pumped to a wastewater treatment unit (WWTU), and then discharged to the City of Delaware's POTW. The wash water from the corrugator is directly discharged to the POTW.

WWTU filter cake - The filter cake from the WWTU is nonhazardous and is disposed of as solid waste.

Scrap paper - All of the facility's scrap paper is collected, baled, and sent back to the company's paper mills to be re-pulped and reused.

Weyerhaeuser is ISO 14001 certified.
