Dear Mr. Cokonougher:

Thank you for accompanying me during Ohio EPA's August 7, 2013 complaint investigation of EZ Oil Change's facility in Washington C.H., Ohio. I inspected EZ Oil Change to determine its compliance with Ohio's used oil laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). The complaint alleged that EZ oil Change employees were mismanaging used oil and dumping oil down sump drains.

Although there was no evidence of used oil dumping, I found the following violation of Ohio's used oil laws.

- **Used Oil Storage Requirements for Generators (OAC Rule 3745-279-22 (C)):** Containers and aboveground tanks used to store used oil at generator facilities must be labeled or marked clearly with the words "Used Oil". At the time of the inspection, eight 55 gallon drums and one aboveground tank were not labeled as "Used Oil".

Documentation of corrected labeling received August 13, 2013. No further action required.
