NOTICE OF VIOLATION - ACTION REQUIRED

Subject: Failure to Monitor Drinking Water

Tree Haven Campground Inc is in violation of Ohio Administrative Code Rule 3745-81-23 for failing to monitor your drinking water during the January 1, 2009 to December 31, 2009 monitoring period and/or report results for the following contaminants: NITRATE (AS N)

In order to return to compliance, Tree Haven Campground Inc must take the following actions:

1. Immediately collect a sample of your drinking water from the entry point (first tap after treatment).
2. Submit the sample for analysis to a certified laboratory on the enclosed list.
3. Notify your customers using the enclosed instructions and public notice.
4. Complete and return the enclosed verification form to this office.

DRINKING WATER NOTICE

Monitoring requirements not met for Tree Haven Campground Inc

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During the January 1, 2009 to December 31, 2009 time period we did not monitor for the following contaminants and therefore cannot be sure of the quality of our drinking water during that time: NITRATE (AS N).

What Should I Do?
