**Subject: Failure to Monitor Drinking Water**

Stock Equipment Company is in violation of Ohio Administrative Code Rule (OAC) 3745-81-24 for failing to monitor your drinking water during the First Quarter of 2009 monitoring period and/or report results for the following contaminants: VOLATILE ORGANIC CONTAMINANTS.

**In order to return to compliance**, Stock Equipment Company must take the following actions:

1. Immediately collect a sample of your drinking water from the entry point (first tap after treatment).
2. Submit the sample for analysis to a certified laboratory on the enclosed list.
3. Notify your customers using the enclosed instructions and public notice.
4. Complete and return the enclosed verification form to this office.

Your prompt attention to this matter is greatly appreciated. Continued noncompliance may lead to enforcement actions. If you have any questions or if the required sample was tested, please call me at (614) 644-2752.

# DRINKING WATER NOTICE

## Monitoring requirements not met for Stock Equipment Company

*We are required to monitor your drinking water for specific contaminants on a regular basis.
