Dear Mr. Paul:

On September 11, 2013, I, as a representative of the Ohio EPA's Division of Materials and Waste Management, conducted an inspection of Chromatic Inc. (Chromatic) at 839 East 63rd Street, Cleveland, for compliance with Ohio's hazardous waste and used oil regulations. You represented Chromatic during that inspection.

Chromatic operates a decorative chrome electroplating facility. No hazardous wastes other than universal waste lamps were observed during the inspection. The facility generates used materials that exhibit hazardous waste characteristics (e.g., spent chrome plating bath that exhibits D002 and D007) that are recycled without reclamation and therefore are not regulated as wastes.

The facility also generates used lamps which are managed as universal waste.

The inspection included a review of the facility's operations, as well as waste management practices and documentation. This letter identifies violations observed during the inspection and steps that must be taken to address those violations. Based on the facility documents reviewed and observations made during the facility walk-through, Ohio EPA has determined that Chromatic has violated the following state universal waste regulations.

1. **OAC Rule 3745-273-15(C) Small Quantity Handler Must Have System To Demonstrate Length Of Accumulation.**
2. **OAC 3745-273-273-15(A) Small Quantity Handler May Only Accumulate For One Year Unless Additional Accumulation Time Is Necessary To Facilitate Proper Recovery, Treatment Or Disposal.**
3. **OAC 3745-273-13(D)(1) Small Quantity Handler Must Contain Lamps In Proper Containers Or Packaging And Containers Or Packaging Must Be Closed.**

The facility generates used fluorescent lamps which it manages as universal waste and is classified as a small quantity handler of universal waste.

Approximately eight boxes of used 8-foot fluorescent lamps were observed in the maintenance shop. Most of the boxes were not closed.

Due to lack of access I could not determine if the date indicating when lamps were first placed in the box was marked on each container or if each container was labelled with the words "Universal Waste - Lamp(s)" or "Waste Lamp(s)" or "Used Lamp(s)". You thought that probably not all boxes were marked as required.

No documentation for any shipments for used lamps was provided. Reportedly many of the used lamps in these containers were generated during a recent re-lamping project. However, given the lack of documentation of lamp shipments, it appears likely that at least some of the lamps had been generated earlier and could have been on-site for more than one year.

These practices were not in compliance with the above cited regulations.

To return to compliance for these violations Chromatic must:

- Close all containers holding used lamps;
- Label each container of used fluorescent lamps with one of these words "Universal Waste - Lamp(s)" or "Waste Lamp(s)" or "Used Lamp(s)";
- Mark each container with the date, estimated to the best of your ability, that lamps were first placed in the container;
- Promptly ship the used lamps currently on-site to a recycler of used fluorescent lamps; and,
- Within 14 days of receipt of this letter, provide photos of the properly labelled and closed containers and a copy of the shipping paper for the recycled lamps to this office.

Enclosed you will find a copy of the checklists completed during the September 11, 2013 inspection.

Chromatic needs to immediately take the necessary measures to return to compliance with Ohio's environmental laws. Within 14 days of receipt of this letter, Chromatic is requested to provide documentation to this office including the steps taken to abate the violations cited above. Documentation of steps taken to return to compliance includes written correspondence, updated policies, and photographs, as appropriate, and may be submitted via the postal service or electronically to neil.wasilk@epa.ohio.gov.

Please be advised that violations cited above will continue until the violations have been properly abated. Failure to comply with Chapter 3734 of the Ohio Revised Code and rules promulgated thereunder may result in a civil penalty of up to \$10,000 per day for each violation. It is imperative that you return to compliance. If circumstances delay the abatement of violations, Chromatic is requested to submit written correspondence of the steps that will be taken by date certain to attain compliance.

Facility generates used materials that exhibit hazardous waste characteristics (e.g., spent chrome plating bath that exhibit D002 and D007) that at the time of inspection are recycled without reclamation and therefore are not currently regulated as wastes.

Facility is a nickel chrome decorative electroplating plating job shop mostly plating on carbon steel with a small volume of plating on brass parts. The facility does not do welding, machining or metal fabricating.

The facility generates spent plating baths (chrome & nickel) on roughly a 5 to 7 year interval. The facility generates used materials that exhibit hazardous waste characteristics (e.g., spent chrome plating bath that exhibits D002 and D007) that are recycled as ingredients in an industrial process without reclamation and therefore are not regulated as wastes. Consequently the facility currently does not generate any hazardous wastes. When shipping spent baths, the plating solutions are pumped directly from plating tank to tank truck without any intermediate storage.

The facility does not generate a F006 waste stream and it does not have a wastewater treatment plant. Facility uses an ion exchange unit and recycles rinse waters. Rinse water overflow goes to a pH adjustment tank prior to discharge to NEORSDD.

No used oil is generated. Lead acid batteries are returned to supplier of new batteries. Used fluorescent lamps are collected for management as universal waste.
