Dear Mr. Weisenburger:

This office received a complaint on August 30, 2013, concerning open burning being conducted on your property. My investigation, conducted on August 3, 2013, shows a burn site has been used to burn various materials for disposal within 1000' of adjacent residences in an unrestricted area. Evidence of the following materials was observed in the burn site on the property: construction and demolition debris; shingles; doors; misc. metal parts; vinyl siding; brush; kitchen sinks, and; plumbing parts.

Based on these findings, there is sufficient evidence to determine that illegal open burning did occur and the complaint is justified. This is a violation of both Ohio Administrative Code (OAC) rule 3745-19-04(A) and Ohio Revised Code (ORC) 3704.05.

Because the fire has been extinguished, you are no longer in violation and the property is considered to have returned to compliance with the above cited violations.

A copy of the OAC rules pertaining to open burning has been enclosed for your review. To be clear, as a commercial business, you are not permitted to burn any construction or demolition wastes either on your job site or on the property where your business is based. Furthermore, when burning any type of wastes that are allowed by rule, one must be "no less than 1000' from any inhabited building" not on that property. From a review of the property limits, per the Putnam County Auditor, it has been determined that there is no point on the property where that 1000' setback limit can be achieved, therefore, you are not permitted to burn any materials for disposal on the property. This is also applicable to your adjacent residential property.



Please note that the submission of the requested information to respond to this letter does not constitute waiver of the Ohio EPA's authority to seek civil penalties as provided in Section 3704.06 of the Ohio Revised Code. Ohio EPA will determine later whether to pursue such penalties in this case. The decision on whether to pursue or decline to pursue such penalties regarding this matter is dependent on several factors, one of which is your future compliance with applicable Ohio EPA requirements.
