Dear Mr. Sano:

Thank you and Dan Kish for accompanying me during my September 10, 2013 inspection of Presrite Corporation (Presrite) in Cleveland, Ohio. I inspected Presrite to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). In addition to the inspection for compliance with Ohio's hazardous waste rules, the facility was inspected for compliance with Ohio's used oil and universal hazardous waste rules. My inspection included a review of company operations and written documentation.

Presrite is a mechanical metal forging operation. Various sizes of steel bar stock is cut to length, heated, then forged into various dyes by metal stamping (forging) machines. Metal scale is produced during the shot blasting of forged pieces. This material is collected and disposed of as solid waste. A water/oil mix is sprayed onto each dye prior to each press cycle to ensure release of the forged part. The excess water/oil is collected in a tank beneath each press which are emptied into totes once per week. Hazardous waste currently generated consists of crushed fluorescent bulbs (D009) collected in a satellite accumulation 55-gallon drum located in the maintenance area. When full, the crushed lamps are managed as a hazardous waste. The facility also generates some universal waste batteries which are recycled.

No violations of Ohio's hazardous waste rules were discovered during my inspection. The inspection did reveal the following violation of Ohio's used oil rules.

1. **OAC Rule 3745-279-22(C), Used Oil Generator Standards:** Containers, above ground tanks, and fill pipes used for underground tanks used to accumulate used oil must be clearly marked "Used Oil." During my inspection I observed the 250 gallon totes used to accumulate used oil. They were not labeled with the words "used oil,"


a violation of OAC 3745-279-22(C). To abate this violation, please submit a photograph of each tote used for accumulating used oil showing they are now labeled "used oil."

Presrite needs to immediately take the necessary measures to return to compliance with Ohio's environmental laws. Within 14 days of receipt of this letter, Presrite is requested to provide documentation to this office including the steps taken to abate the violation one, cited above. Documentation of steps taken to return to compliance includes written correspondence and updated policies, as appropriate, and may be submitted via the postal service or electronically to tom.roth@epa.ohio.gov.

Please be advised that the violation cited above will continue until the violation has been properly abated. Failure to comply with Chapter 3734 of the Ohio Revised Code and rules promulgated thereunder may result in a civil penalty of up to \$10,000 per day for each violation. It is imperative that you return to compliance. If circumstances delay the abatement of the violation, Presrite is requested to submit written correspondence of the steps that will be taken by date certain to attain compliance.
