**Notice of Violation**

Dear Mr. Snyder:

On August 13, 2013, Kara Reynolds and I conducted a compliance evaluation inspection at Snyder Buick, Cadillac & GMC, Inc., Service Department (SSD) located at 1421 N. Scott Street in Napoleon, Ohio. We inspected SSD to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). Pollution prevention options were also discussed during this inspection.

During our inspection, we spoke with Gary Hurst and Steve Phipps, inspected your facility and reviewed applicable paperwork. SSD is a full-service automotive service shop (i.e. oil changes and service repairs). SSD generates used oil which is stored in a 1,000-gallon above ground storage tank. SSD burns the used oil in an on-site burner to heat the building. Used oil filters are hot drained and managed as a solid waste.

SSD has one parts washer on-site and Vesco Oil picks up the spent solvent (D001) once a month. Shop towels are laundered by Miller Textile. No painting is done at this facility. SSD has not generated any spent fluorescent lamps since the facility switched all of their lighting fixtures over to T5 lamps. Once the fluorescent lamps are no longer under warranty, SSD plans to manage them as universal waste. A copy of Fluorescent Lamps: What You Should Know, is enclosed. I recommend that you review this document and contact me if you have any questions.

At the time of our inspection, SSD was operating as a conditionally exempt small quantity generator of hazardous waste.

We found the following violation of Ohio's hazardous waste laws:

**1. Labeling: OAC Rule 3745-279-22(C)(1):**

Containers, aboveground tanks, and fill pipes used for underground storage tanks shall be labeled or marked clearly with the words "used oil."

SSD had one 1,000-gallon storage tank, a designated dump station, and multiple portable containers of used oil that were not properly labeled "Used Oil".

In order to correct this violation, SSD must properly label the storage tank, dump station, and portable containers with the words "Used Oil" and submit photographic documentation to demonstrate compliance.

A copy of the fact sheet, The Regulation of Used Oil: An Overview for Ohio Businesses Who Generate Used Oil, was given to you at the time of our inspection.

SSD may want to consider recycling the used oil filters once they have been properly drained. A list of used oil filter recyclers is enclosed. Please review this information and contact me if you have any questions.

Also enclosed is a summary chart which outlines the new federal rule for solvent-contaminated rags that will go final in January 2014. Ohio will be required to adopt this rule. Here is a link to the USEPA webpage which has additional information:

SSD needs to immediately take the necessary measures to return to compliance with Ohio's environmental laws. Within **14 days** of receipt of this letter, SSD is requested to provide documentation to this office including the steps taken to abate the violations cited above.

Documentation of steps taken to return to compliance includes written correspondence, updated policies, and photographs, as appropriate, and may be submitted via the postal service or electronically to [melissa.boyers@epa.ohio.gov](mailto:melissa.boyers@epa.ohio.gov).
