To Whom It May Concern:

On Monday, August 5, 2013, I inspected the Industry Products Company site in Piqua, Ohio to determine compliance with the site's National Pollutant Discharge Elimination System (NPDES) construction site storm water discharge permit. I did not speak with anyone at the site.

Based on my observations, there were no obvious violations of the project's storm water discharge permit. I did not review the sediment control inspections logs or the site's Storm Water Pollution Prevention Plan (SWP3) before my inspection. The project is now complete and grass is established on the site.

As a reminder, please note that when construction is complete, and all areas of the site have been permanently stabilized with vegetation or other ground cover, the construction permit must be terminated. 
