Dear Ms. Adkins:

During a review of Ohio EPA's electronic Discharge Monitoring Report (eDMR) information for the above referenced facility located at 1600 Lennox-New Lyme Road, Lenox Township, Ashtabula County, Ohio EPA notes that eDMRs have not been submitted for the months of February and May 2013. This was discussed with Mr. Phil Brazil of your organization on August 1, 2013. To-date this information has not been received.

If data has been collected but not placed into the eDMR system, reports may still be filed or amended through your normal eDMR reporting procedures. If data has not been collected, please provide an explanation as to why this data was not collected and reported as prescribed by your National Pollutant Discharge Elimination System (NPDES) permit.

Please inform this office, in writing, within 30 days of the date of this letter as to the actions that have been or will be taken to correct the above noncompliance or explanations if you believe the noncompliance issues noted are in error. Your response to this letter should include the dates that the actions have been or will be completed.

Please be advised that past or present issues of noncompliance can continue as subjects of future enforcement actions by Ohio EPA.
