This letter serves as a Notice of Violation to you for failure to submit a timely permit application for renewal of the permit identified below. This failure to submit a complete and timely application has resulted in the loss of the "application shield" provided by Ohio Revised Code (ORC) section 119.06, for the air contaminant sources (emissions units) identified in the table below.

Be advised that submission of a permit renewal application will not reinstate the "application shield" provided by (ORC) section 119.06.
