**RESOLUTION OF VIOLATIONS
NOTICE OF VIOLATION FOLLOW-UP LETTER**

Dear Ms. Dilley:

On April 30, 2013, the Cleveland Division of Air Quality (CDAQ) inspected Lehigh Gas, OHLG-UST1, LLC dba 10300 Brookpark Brooklyn, LLC (10300 Brookpark Brooklyn, LLC) located at 10300 Brookpark Road in Brooklyn.

On May 2, 2013, CDAQ issued a Notice of Violation requiring 10300 Brookpark Brooklyn, LLC to complete the necessary training and then submit proof of attendance and completion of training. Also, 10300 Brookpark Brooklyn, LLC failed to maintain a copy on site of the most recently issued operating permit from the Ohio EPA. A copy of the most recently issued permit was mailed directly to 10300 Brookpark Road by CDAQ on April 30, 2013.

CDAQ is in receipt of a corrective action plan dated May 22, 2013, at which time a Stage II compliance specialist certificate was submitted on behalf of 10300 Brookpark Brooklyn, LLC via e-mail.

Appropriate steps were taken to bring the source into compliance. CDAQ has determined that no further enforcement action is warranted at this time, but reserves its right to take such action in the future if necessary.

CDAQ issues this letter with Ohio EPA's concurrence and does not excuse any violations of local, state and federal laws or regulations regarding air pollution control. Violations of air pollution control laws may be pursued in local court or referred to Ohio EPA or U.S. EPA for further enforcement action.
