Failure to submit the reports by April 15, 2011, is a violation of Ohio Administrative Code (OAC) rule 3745-78-02 and OAC rule 3745-15-03. This letter serves as a notice that failure to fulfill your obligation to submit these reports will result in the initiation of an Enforcement Action Request to the Ohio EPA, Central Office. **Please respond within thirty days of receipt of this letter with a FER/EIS for 2010 submitted via the eBusiness Center: Air Services indicating the actual emissions data for the facility.**

A letter was sent on January 12, 2011, to this facility and indicated these emissions reporting requirements and provided guidance on completing the report.
