A Title V Fee Emissions Report (FER) and Emissions Inventory Summary (EIS) for calendar year 2010 was due on April 15, 2011, for the facility identified above. Failure to submit the reports by April 15, 2011, is a violation of Ohio Administrative Code (OAC) rule 3745-78-02 and OAC rule 3745-15-03. This letter serves as a notice that failure to fulfill your obligation to submit these reports will result in the initiation of an Enforcement Action Request to the Ohio EPA, Central Office. **Please respond within thirty days of receipt of this letter with a FER/EIS for 2010 submitted via the eBusiness Center: Air Services indicating the actual emissions data for the facility.**

A letter was sent on January 12, 2011, to this facility and indicated these emissions reporting requirements and provided guidance on completing the report.
