Dear J. Dooley,

A Title V Fee Emissions Report (FER), Emissions Inventory Summary (EIS), and Emissions Statement (ES) for calendar year 2006 was due on April 16, 2007 for the facility identified above. Failure to submit the reports by April 16, 2007, was a violation of Ohio Administrative Code (OAC) rule 3745-78-02 and OAC rule 3745-15-03. This letter serves as a notice that failure to fulfill your obligation to submit these reports will result in the initiation of an Enforcement Action Request to the Ohio EPA, Central Office. **Please respond within thirty days of receipt of this letter with a FER/EIS/ES for 2006 submitted via the STARShip software indicating the actual emissions data for the facility.**
