

NOTICE OF VIOLATION

The City of Toledo Division of Environmental Services (TDOES) hereby serves notice that:

has violated the following environmental laws, orders, rules, or regulations on the indicated date at the above address.

<p>40 CFR Parts 63.322(k), (m), (n) and (o); 40 CFR Part 63.323(a)(1)(ii) and 40 CFR Parts 63.324(d)(1),(d)(3),(d)(4),(d)(5) Permit to Operate (PTO), terms Part II., sections C.1., C.2., and C.3.b. thru g. Monitoring and/or Record Keeping Requirements The permittee is required to perform weekly visual inspections as part of a leak detection and repair program; repair leaks within 24 hours, or have repair parts ordered within 2 days and have them installed within 5 days of receipt. The permittee is required to keep a written log of these activities.</p> <p>The operator of a dry cleaning system shall inspect for vapor leaks monthly using a halogenated hydrocarbon detector or a PCE gas analyzer.</p> <p>The temperature of the air-perchloroethylene gas-vapor stream on the outlet side of the refrigerated condenser shall be measured weekly with a temperature sensor.</p> <p>Records shall be kept of the volume of perchloroethylene purchased each month (if no perchloroethylene is purchased during a given month, then the entry into the log shall be zero gallons).</p>	<p>On April 27, 2009 during a facility inspection the operator at this facility did not keep logs of the required weekly visual inspections, of repair dates and parts ordered and a log of control equipment maintenance.</p> <p>On April 27, 2009 during a facility inspection the operator at this facility did not keep a log of the required monthly vapor leak inspections using a halogenated hydrocarbon detector or PCE gas analyzer.</p> <p>On April 27, 2009 during a facility inspection the operator at this facility did not keep a log of the temperature of the air-perchloroethylene gas-vapor stream on the outlet side of the refrigerated condenser.</p> <p>On April 27, 2009 during a facility inspection the operator at this facility did not keep a log of the volume of perchloroethylene purchased each month, including zeros.</p>
<p>40 CFR 63.324(f) The permittee was to submit a notification of compliance on or before July 28, 2008.</p>	<p>To date, this notification was not received.</p>

The above violation(s) may subject the violator to **penalties** of up to \$25,000 per violation. It is possible that a penalty will be assessed in this case. If a penalty is to be assessed, the amount will be determined after your response is reviewed.

Required Actions

Within fourteen (14) days of receipt of this Notice of Violation, the permittee shall:

1. Abate the violations or provide for an acceptable remedy.
2. Reply in writing to this Notice of Violation within fourteen (14) days of receipt. The reply shall include:
 - a. descriptions and dates of actions taken thus far to abate the violation(s);
 - b. descriptions and expeditious time schedule of actions yet to be taken to remedy the violation(s); and
 - c. descriptions of actions taken or to be taken to prevent recurrence of the violation(s).

Recommended Remedial Actions

It is recommended that you consider the following suggestions:

- Implement all monitoring, recordkeeping, reporting and testing requirements of the Permit to Operate for Arrowhead Cleaners.
- Implement the additional requirements of the amended MACT, 40 CFR 63, subpart M, in particular Parts 63.322(o) and 63.324 (f).
- Use the halogenated hydrocarbon detector at least once a month and count as one of the weekly visual inspections.
- Continue to monitor the waste material generated behind the dry cleaning machine.
