NOTICE OF VIOLATION FOLLOW-UP LETTER**

Dear Mr. Moon:

On 5/5/11, the Cleveland Division of Air Quality (CDAQ) issued a Notice of Violation requiring Lakeshore Sunoco to submit a PTIO or PBR application for the current ownership; Provide Stage II Compliance Specialist Training for the site manager and submit a copy of the certificate of completion; and provide a description of how Lakeshore Sunoco will maintain all required records going forward. CDAQ is in receipt of a corrective action plan dated 6/10/11 that included the Stage II Compliance Training Certificate; copies of prior year's Stage II test results and a narrative indicating that instructions have been relayed to the site regarding recordkeeping. Additionally, a new PBR application was not required as current ownership has remained the same, only a change in site management has occurred.

The corrective action plan was received in a timely manner and appropriate steps were taken to bring the source into compliance. CDAQ has determined that no further enforcement action is warranted at this time, but reserves its right to take such action in the future if necessary.

CDAQ issues this letter with Ohio EPA's concurrence and does not excuse any violations of local, state and federal laws or regulations regarding air pollution control. Violations of air pollution control laws may be pursued in local court or referred to Ohio EPA or U.S. EPA for further enforcement action.
