NOTICE OF VIOLATION FOLLOW-UP LETTER**

Dear Mr. Pruc:

On 8 July 2008, the Cleveland Division of Air Quality (CDAQ) issued a Notice of Violation requiring T & B Foundry Company (T & B Foundry) to submit F002's quarterly deviation reports, P902's quarterly operating reports and submit a permit to install (PTI) application for emission unit F002. CDAQ received F002's quarterly deviation reports and P902's quarterly operating reports for the first and second quarters of 2008 on 25 July 2008. CDAQ received the PTI for F002 on 12 December 2008.

The corrective action was received and appropriate steps were taken to bring the source into compliance. CDAQ determined that no further enforcement action is warranted at this time, but reserves its right to take such action in the future if necessary.

CDAQ issues this letter with Ohio EPA's concurrence and does not excuse any violations of local, state and federal laws or regulations regarding air pollution control. Violations of air pollution control laws may be pursued in local court or referred to Ohio EPA or U.S. EPA for further enforcement action.
