NOTICE OF VIOLATION FOLLOW-UP LETTER**

Dear Mr. Al Ahmed:

On February 10, 2011, the Cleveland Division of Air Quality (CDAQ) inspected Clarkway-Lee Gas Mart and witnessed a failed Stage II test.

On February 10, 2011, CDAQ issued a Notice of Violation requiring Clarkway-Lee Gas Mart to obtain a city permit-to-operate by submitting a city permit fee for calendar year 2010 as well as make all repairs and schedule another Stage II test within thirty (30) days of your receipt of the letter.

No action was taken by Clarkway-Lee Gas Mart in that thirty (30) day period, so a Second Notice of Violation was issued on April 18, 2011 for the same violations.

CDAQ is in receipt of a city permit fee for calendar year 2010 dated April 28, 2011. CDAQ also witnessed a passing Stage II test performed by Environmental Compliance Technologies on June 14, 2011.

The corrective action plan was received and appropriate steps were taken to bring the source into compliance. CDAQ has determined that no further enforcement action is warranted at this time, but reserves its right to take such action in the future if necessary.

CDAQ issues this letter with Ohio EPA's concurrence and does not excuse any violations of local, state and federal laws or regulations regarding air pollution control. Violations of air pollution control laws may be pursued in local court or referred to Ohio EPA or U.S. EPA for further enforcement action.
