NOTICE OF VIOLATION FOLLOW-UP LETTER

Dear Ms. Smith:

On March 16, 2009, the Cleveland Division of Air Quality (CDAQ) issued a Notice of Violation requiring All County Pet Crematory (All County) to submit a corrective action plan stating how monthly afterburner inspections and cleanings will be performed and when permit terms and conditions will be visibly posted near the incinerator.

CDAQ is in receipt of a corrective action plan dated March 20, 2009, stating that the terms and conditions are clearly posted by the unit and that All County is working with Loreto Agdinaoay, CDAQ, in regards to the monthly inspection and cleaning of the afterburner.

You are expected to comply with the recommendations as suggested by Loreto Agdinaoay when they are made.

The corrective action plan was received in a timely manner and appropriate steps were taken to bring the source into compliance. CDAQ has determined that no further enforcement action is warranted at this time, but reserves its right to take such action in the future if necessary.

CDAQ issues this letter with Ohio EPA's concurrence and does not excuse any violations of local, state and federal laws or regulations regarding air pollution control. Violations of air pollution control laws may be pursued in local court or referred to Ohio EPA or U.S. EPA for further enforcement action.
