NOTICE OF VIOLATION

Dear Mr. Mingus:

On October 27, 2009, the Cleveland Division of Air Quality (CDAQ) inspected Qualico located at 3201 East 66<sup>th</sup> St. in Cleveland. The following violation of Ohio air statutes and regulations was found at the time of the inspection:

Failure to electronically submit quarterly deviation reports for the first, second and third quarters of 2009, which were due April 30, 2009, July 31, 2009, and October 31, 2009, is a violation of the General Terms and Conditions of your permit and Ohio Administrative Code 3745-15-03 (C).

CDAQ is in receipt of the quarterly deviation reports for the second and third quarters of 2009 that Qualico electronically submitted on November 10, 2009. However, CDAQ has not received an electronic submission of the deviation report for the first quarter of 2009.

Unless you undertake some type of corrective action with respect to the above noted violations, you will remain in non-compliance. CDAQ requests that Qualico submit an electronic copy of the deviation report through Air Services for the first quarter of 2009 within 14 days of the receipt of this letter.

Violations of Ohio air pollution laws and /or permit terms and conditions are subject to the penalties stipulated in Ohio Revised Code Section 3704.99(A), which allows fines of not more than twenty-five thousand dollars or imprisonment for not more than one year, or both, for each violation.

Free assistance with state and/or federal regulations, rules, laws or permit conditions can be provided at no charge through the Ohio EPA Office of Compliance Assistance and Pollution Prevention (OCAPP). CDAQ makes no guarantee that the facility will meet the qualifying guidelines established by OCAPP.

OCAPP can also provide assistance to facilities that want to investigate methods of pollution prevention to reduce raw material usage and waste production. Again, there is no charge for their services.


