NOTICE OF VIOLATION FOLLOW-UP LETTER**

Dear Mr. Consolo:

On April 8, 2011, the Cleveland Division of Air Quality (CDAQ) issued a Notice of Violation requiring Plastic Platers, Inc:

1. Prepare and submit a copy of an operation and maintenance plan for EU P004: Decorative Chrome Plating Line (Received June 30, 2011).
2. Begin recording the surface tension of the chromic acid bath for EU P004, and submit a copy of two weeks of records (Received June 30, 2011).
3. Submit an initial notification report for EU P004 (Received June 30, 2011).
4. Submit an annual ongoing compliance status report for EU P004 (Received June 30, 2011).
5. Begin submitting quarterly deviation reports for EU P004 (Received June 30, 2011).
6. Begin submitting semi-annual deviation reports for EU P004 (Received June 30, 2011).

The corrective action plan was received and appropriate steps were taken to bring the source into compliance. CDAQ has determined that no further enforcement action is warranted at this time, but reserves its right to take such action in the future if necessary.

CDAQ issues this letter with Ohio EPA's concurrence and does not excuse any violations of local, state and federal laws or regulations regarding air pollution control. Violations of air pollution control laws may be pursued in local court or referred to Ohio EPA or U.S. EPA for further enforcement action.
