NOTICE OF VIOLATION FOLLOW-UP LETTER**

Dear Mr. Scanlon:

On 8/21/08, the Cleveland Division of Air Quality (CDAQ) issued a Notice of Violation requiring North American Manufacturing Co., Ltd. (NAMCO) to submit a corrective action plan that details procedures to monitor and control visible emissions (VE) when conducting fuel testing operations. CDAQ is in receipt of a corrective action plan dated 9/9/08 that establishes procedures for third party pre-testing of potential fuels, pre-heating of emissions units to eliminate VE, VE monitoring during testing, record keeping and test termination steps if VE is detected.

The corrective action plan was received in a timely manner and appropriate steps were taken to bring the source into compliance. CDAQ has determined that no further enforcement action is warranted at this time, but reserves its right to take such action in the future if necessary.

CDAQ issues this letter with Ohio EPA's concurrence and does not excuse any violations of local, state and federal laws or regulations regarding air pollution control. Violations of air pollution control laws may be pursued in local court or referred to Ohio EPA or U.S. EPA for further enforcement action.
