NOTICE OF VIOLATION FOLLOW-UP LETTER**

Dear Mr. Ali:

On February 7, 2011, the Cleveland Division of Air Quality (CDAQ) issued a Second Notice of Violation to Strongsville Clark for failure to provide proof of attendance and completion of Stage II training required by the Ohio EPA for the operator or local manager of your GDF.

CDAQ is in receipt of a copy of the required training as of March 23, 2011; thus, appropriate steps were taken to bring your GDF into compliance. CDAQ has determined that no further enforcement action is warranted at this time, but reserves its right to take such action in the future if necessary.

Please note that you are expected to comply with your stated actions as written in your letter dated February 2, 2011, to CDAQ. Failure to do so may result in referral to Ohio EPA or U.S. EPA for further enforcement action. Fulfillment of your commitments included in your corrective action plan and/or any modifications contained within this letter does not constitute a waiver of CDAQ's ability to refer this matter to Ohio EPA or U.S. EPA for further enforcement action.

Please also note that Ohio Administrative Code rule 3745-21-09(DDD)(3), requires the following records to be kept by you:

- Monthly records of the quantity of gasoline delivered to the facility;
- The results of any tests performed pursuant to paragraph (DDD)(2) of OAC rule 3745-21-09;
- A log of the date and description of all repair and maintenance work performed, or any other modifications made to the vapor control system;
- Proof of attendance and completion of the training required by the Ohio EPA for the operator or local manager of the GDF; and,



- Copies of all completed post test inspection forms.

CDAQ issues this letter with Ohio EPA's concurrence and does not excuse any violations of local, state and federal laws or regulations regarding air pollution control. Violations of air pollution control laws may be pursued in local court or referred to Ohio EPA or U.S. EPA for further enforcement action.
