Dear Ms. Zeigler:

After a discussion with you on May 31, 2012, it came to my attention that this facility operates one petroleum based dry cleaning machine. This facility and its associated emission unit are not currently permitted by this agency. After a review of Ohio EPA regulations, the agency does not currently have a permit exemption under OAC 3745-31-03 for petroleum based dry cleaning operations; therefore, this emission unit would require a permit.

The installation and operation of this emission unit is in violation of OAC rule 3745-31-02 and Ohio Revised Code 3704.05. Therefore, the facility is required to submit a Permit to Install/Operate (PTIO) application for this emission unit. A complete application for the air contaminant source would include a PTIO application (form 3150a), the appropriate Emissions Activity Category (EAC) form for your operations, a process flow diagram, and emissions calculations. These forms can be found on the web at <http://www.epa.ohio.gov/dapc/fops/eacforms.aspx>, and should be submitted by no later than July 6, 2012.

If you need assistance in completing the application forms, please contact either me or the Office of Compliance Assistance and Pollution Prevention (OCAPP). OCAPP offers free, confidential assistance to small businesses. 
