**RESOLUTION OF VIOLATIONS  
NOTICE OF VIOLATION FOLLOW-UP LETTER**

Dear Mr. Harris:

On March 23, 2012, the Cleveland Division of Air Quality (CDAQ) issued a Notice of Violation requiring Karr's Custom Cleaners to submit an Annual Permit Evaluation Report (PER) for calendar year 2011 within fourteen (14) day of receipt of the letter.

Karr's Custom Cleaners failed to submit a PER for the reporting period of January 1 – December 31, 2011, which was due no later than February 15, 2012. PERs are a reporting requirement specified in permit-to-install/operate (PTIO) # P0107879, Authorization (page 1) and Emission Unit Terms and Conditions section C.(1)(e)2. (page 15), issued to Karr's Custom Cleaners on April 4, 2011.

CDAQ then issued a Second Notice of Violation on May 3, 2012, after no action was taken from Karr's Custom Cleaners. CDAQ is in receipt of a corrective action dated August 1, 2012, at which time a PER was submitted for calendar year 2011 for Karr's Custom Cleaners.

Appropriate steps were taken to bring the source into compliance. CDAQ has determined that no further enforcement action is warranted at this time, but reserves its right to take such action in the future if necessary. Please note that the PER for calendar year 2012 is due no later than February 15, 2013.

CDAQ issues this letter with Ohio EPA's concurrence and does not excuse any violations of local, state and federal laws or regulations regarding air pollution control. Violations of air pollution control laws may be pursued in local court or referred to Ohio EPA or U.S. EPA for further enforcement action.
