RE: NOTICE OF VIOLATION

Dear Mr. Klein:

This is in follow-up to my facility visit on October 7, 2009 at your Akron, Ohio facility (1677010807). I would like to thank you for your cooperation during my visit.


I must advise you that Belle-Aire Cleaners is operating emissions unit D001 in violation of Section 63.322(o)(3) of 40 CFR Part 63, Subpart M. The July 27, 2006 revisions to 40 CFR Part 63, Subpart M required all existing transfer machines to be removed from service by July 28, 2008. The continued operation of the transfer machine past July 28, 2008 constitutes a violation of 40 CFR Part 63, Subpart M.

No later than fourteen (14 days) from the receipt of this letter, please submit a complete compliance plan and time schedule to this agency to bring emissions unit D001 into compliance with 40 CFR Part 63, Subpart M. The plan and schedule must contain specific steps that either are or will be taken to bring this facility into compliance along with their corresponding deadlines or milestone dates. If you need additional time, please notify this agency in writing.

The submission of the compliance plan and time schedule does not constitute a waiver of the authority of either the Ohio Environmental Protection Agency (Ohio EPA) or US EPA to seek penalties in this matter. The decision to pursue, or decline to pursue, additional enforcement action in this case will be made at a later date.


