This letter serves as a Notice of Violation to you for the failure to submit a timely permit application for renewal of the permit identified above which expired on 11/17/2010. This failure to submit a complete and timely application, has resulted in the loss of the "application shield" provided by Ohio Revised Code (ORC) section 119.06, for the air contaminant sources (emissions units) identified in the table below.

Continued operation of these emissions units after the expiration date of the permit, without a valid renewal permit being issued by the Director, will be a violation of OAC rule 3745-31-02(A)(1)(c). Be advised that submission of a permit renewal application, will not reinstate the "application shield" provided by (ORC) section 119.06.

Please submit a complete renewal application to Ohio EPA as soon as possible, but no later than 30 days from receipt of this notice.

Acceptance by the Ohio EPA of the renewal application does not constitute a waiver of the Ohio EPA's authority to seek civil penalties as provided in Section 3704.06 of the Revised Code. The determination to pursue or to decline to pursue such penalties in this case will be made by the Ohio EPA at a later date.
