

Submit an application immediately.</p> <p>Equipment: This facility failed Stage II testing on 11/5/08. Timely repair and retesting are required.</p>

Please correct the deficiencies noted. These facilities will be inspected on an annual basis for compliance with the Stage II vapor recovery rule. It is required that you keep record keeping information at a readily available location for inspection.
