Site Deficiency

- All ARAQMD file: This Agency has not received the results of Stage II testing completed in 2011 for all of the above listed stations. Please submit results immediately. EZ Energy is in violation of OAC 3745-21-09 (DDD)(2)(c) which requires the results of testing to be submitted within 30 days of tests completion.
- 2417 Record keeping: The results of Stage II testing for 2008, 2009 & 2010 were not in station file.
- 2401 Record keeping: A certificate of Stage II training and the results of Stage II testing for 2009 & 2010 were not in station file.

Please correct any deficiencies noted. These facilities will be inspected on an annual basis for compliance with the Stage II vapor recovery rule. It is required that you keep record keeping information at a readily available location for inspection. For this Agency, it is requested that you keep copies of the required information at each individual location where all employees can access them.
