**RESOLUTION OF VIOLATIONS  
NOTICE OF VIOLATION FOLLOW-UP LETTER**

Dear Mr. Hadgis:

On August 13, 2012, the Cleveland Division of Air Quality (CDAQ) issued a Notice of Violation requiring Areway Acquisitions, Inc. to electronically submit, via the eBusiness Center, all quarterly deviation reports, semi-annual ongoing compliance status reports, annual Title V Fee Emissions Report, annual Emissions Inventory Summary and annual Title V Compliance Certification for 2011.

CDAQ is in receipt of four quarterly deviation reports and two semi-annual ongoing compliance status reports dated August 31, 2012; an annual Title V Fee Emissions Report and an annual Emissions Inventory Summary dated September 11, 2012; and an annual Title V Compliance Certification dated September 14, 2012.

The corrective action plan was received in a timely manner and appropriate steps were taken to bring the source into compliance. CDAQ has determined that no further enforcement action is warranted at this time, but reserves its right to take such action in the future if necessary.

CDAQ issues this letter with Ohio EPA's concurrence and does not excuse any violations of local, state and federal laws or regulations regarding air pollution control. Violations of air pollution control laws may be pursued in local court or referred to Ohio EPA or U.S. EPA for further enforcement action.
