**RESOLUTION OF VIOLATIONS
NOTICE OF VIOLATION FOLLOW-UP LETTER**

Dear Ms. Brecker:

On 12/7/12, the Cleveland Division of Air Quality (CDAQ) inspected OHLG-UST1 dba 10202 Lorain Cleveland, LLC located at 10202 Lorain Ave. in Cleveland.

On 12/11/12, CDAQ issued a Notice of Violation requiring 10202 Lorain Cleveland, LLC provide Stage II Compliance Specialist Training for the operator or local manager and submit a copy of the certificate of completion along with confirmation that steps have been taken to ensure that copies of the 2012 Stage II Vapor Recovery Test Results and 2012 Stage II Vapor Recovery Post Test Inspection Form are available in the future.

On 12/28/12, CDAQ received electronic copies of the 2012 Stage II Vapor Recovery Test Results and 2012 Stage II Vapor Recovery Post Test Inspection Forms along with assurance that copies were being provided to the station.

On 1/14/13, CDAQ received an electronic copy of the Stage II Compliance Specialist Training Certificate for the operator or local manager.

The corrective action plan was received in a timely manner and appropriate steps were taken to bring the source into compliance. CDAQ has determined that no further enforcement action is warranted at this time, but reserves its right to take such action in the future if necessary.

CDAQ issues this letter with Ohio EPA's concurrence and does not excuse any violations of local, state and federal laws or regulations regarding air pollution control. Violations of air pollution control laws may be pursued in local court or referred to Ohio EPA or U.S. EPA for further enforcement action.
