This letter serves as a Notice of Violation to you for the violation of OAC rule 3745-31-02 for failure to submit a timely permit application for renewal of the permit identified above which expired on 1/29/2013. This failure to submit a complete and timely application, has resulted in the loss of the "application shield" provided by Ohio Revised Code (ORC) section 119.06, for the air contaminant sources (emissions units) identified in the table below.
