**RESOLUTION OF VIOLATIONS
NOTICE OF VIOLATION FOLLOW-UP LETTER**

Dear Ms. Trotter:

On January 10, 2013, the Cleveland Division of Air Quality (CDAQ) issued a Notice of Violation requesting that Trotter's Dry Cleaners submit a Permit Evaluation Report (PER) for calendar year 2011 and obtain City of Cleveland permits-to-operate by submitting city permit fees for calendar years 2008, 2009, 2010 and 2012, within thirty (30) days of receipt of the letter.

CDAQ is in receipt of a PER for calendar year 2011 dated January 31, 2013.

CDAQ then issued a Receipt of Corrective Action Plan (RCAP) letter on February 5, 2013, requesting that Trotter's Dry Cleaners obtain City of Cleveland permits-to-operate by submitting city permit fees for calendar years 2008, 2009, 2010 and 2012, by February 15, 2013. CDAQ received requests for an extension to submit payment or proof of payment ultimately by March 22, 2013. Payments for calendar years 2009 and 2010 were received on March 25, 2013. CDAQ discovered that payments for calendar years 2008, 2011 and 2012 were previously received in a timely manner.

The corrective action was received and appropriate steps were taken to bring the source into compliance. CDAQ has determined that no further enforcement action is warranted at this time, but reserves its right to take such action in the future if necessary.

CDAQ issues this letter with Ohio EPA's concurrence and does not excuse any violations of local, state and federal laws or regulations regarding air pollution control.



Violations of air pollution control laws may be pursued in local court or referred to Ohio EPA or U.S. EPA for further enforcement action.
